Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund when the fund received its first contribution, 04 March 2025 and did not make any further contributions. At the end of the period to 31 December 2025, Anthony incurred a loss after fund charges were deducted of \$23 (that is -0.23% of his initial \$10,000). This gives Anthony a loss after tax of \$126 for the period.


This shows the types of assets that the fund invests in.

## Notes
