#### What is the purpose of this update?

This document tells you how the Hyperion Global Growth Companies PIE Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

Objective: To achieve long-term returns above the MSCI World Net Total Return Index in NZ dollars and minimise the risk of permanent capital loss.

Strategy: The fund invests in growth oriented companies primarily listed on a recognised global exchange, at the time of investment.


The market index return is MSCI World Net Total Return Index in NZ dollars. This has been the market index since the inception of the fund.

### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$3,483 (that is 34.83% of his initial \$10,000). This gives Anthony a return after tax of \$3,461 for the year.




This shows the types of assets that the fund invests in.

#### **Notes**

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. Market index returns have been used until 31 March 2022 and fund returns thereafter. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.
- 2. The bar chart shows fund returns after deducting fees and tax. Tax is deducted at the highest Prescribed Investor Rate of 28%. However, the market index returns are shown before deducting fees and tax.
