Description of this fund


Objective: to perform broadly in line with the return of its investment benchmark before fees and tax over the long-term.

Strategy: aims for high long-run returns by investing in a diversified portfolio weighted towards growth assets but with some income asset exposure.

What are the risks of investing?

Risk indicator for the Foundation Series Growth Fund¹.



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$603 (that is 6.03% of his initial \$10,000). This gives Anthony a total return after tax of \$504 for the year.


What does the fund invest in?
