## How has the fund performed?



### **Example of how this applies to an investor**

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$465 (that is 4.65% of his initial \$10,000). This gives Anthony a return after tax of \$335 for the year.

Actual Investment Mix




Foreign currency was not hedged to New Zealand dollars as at 31 December 2025
