

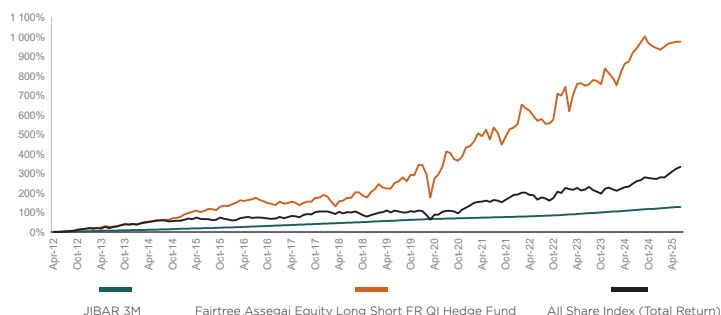
Investment Objective

The objective of the fund is to create long-term wealth for investors by extracting alpha from equity markets.

Fund Profile

The portfolio is managed as a long/short hedge fund, focused on extracting alpha returns from the South African equity market. The funds returns are delivered through fundamental knowledge of South African equities vis-à-vis economic growth and broad economic themes as well as medium to long-term relative valuation opportunities, generating the largest portion of its returns through its directional bias. Relative value pairs, together with absolute longs and shorts seek to stabilize returns in turbulent market conditions, supported by the adjustment to the net exposure.

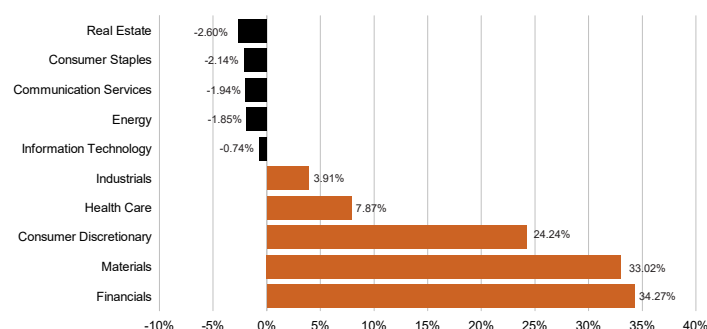
Income Distribution

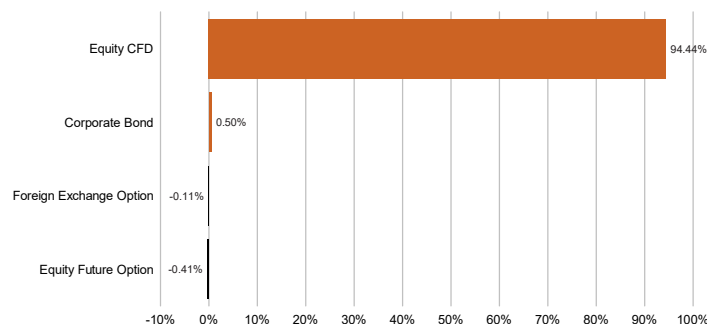

Market Commentary

June 2025 saw global markets recover amid easing inflation and resilient labour data in the US and Europe. The Fed held rates steady, while China's weaker growth and ongoing trade uncertainty limited risk appetite. A temporary US-China tariff pause and strong tech earnings supported equities. Geopolitical tensions, especially the Iran-Israel conflict, drove safe-haven flows into gold. In the US, inflation rose slightly to 2.4%. The Fed kept rates on hold for a fourth consecutive meeting, while the DXY dollar index experienced its worst half-year performance (-10.7%) in more than 30 years.

Oil spiked during the Israel/Iran conflict, over the risks of Iran closing the Straits of Hormuz or either side hitting energy infrastructure in the Persian Gulf. Oil rose from \$64 at end-May to trade over \$80 briefly and settled at \$68, up \$4 or 6.0% in the month. Gas jumped as well - one-third of the world's LNG exports pass through the Straits - with 1m TTF hitting €41 before closing the month down 4.9% at €32.1. Gold rallied into the Middle East crisis and sold off after, ending the month +0.4% while platinum rose by US\$302 or 28% to US\$1359/oz, breaking out of its multi-year level and posting its best month in more than 20 years. The LME Metals Index rose 4.8% and Copper jumped 7.5%.

South African assets tracked the global rally, with stocks posting their best start to the year in this century. Political tensions within the GNU rose after the dismissal of a DA deputy minister for unauthorised travel, although the market impact was limited and the DA remained part of the coalition while withdrawing from certain government engagements. The SARB introduced the idea of a three percent inflation target, which boosted sentiment within the local fixed income markets and strengthened the currency.

South African assets rose in June, with equities at the margin outperforming bonds. The All Share rose 2.4% with the ALBI Index (+2.3%) matching those gains. The rand strengthened 1.6% to R17.71 against the US dollar. R214 yields dropped 22bps to 10.85%. Resources (+4.2%) outperformed industrials (+2.5%) and financials (+1.2%). Key sector leaders were Telecoms (+10.2%), Technology (+6.8%) and Precious Metals (+6.7%). Laggards included General Retail (-5.3%) and Food Producers (-4.3%). MSCI South Africa rose 4.4% in US dollars in June, outperforming MSCI World (+4.3%) but lagging MSCI EM (+6.0%).

The Assegai fund rose 0.1% during June. Long positions in Reinet (+1.1%), the Platinum ETF (+1%), Telkom (+0.8%) and Prosus (+0.4%), as well as a short position in a food producer (+0.4%), added most to performance during the month. Short positions in PGM mines and long positions in retailers detracted most.

Glossary

Net Asset Value (NAV) :	Means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.
Annualised Return :	Is the weighted average compound growth rate over the performance period measured.
Highest & Lowest Return :	The highest and lowest rolling twelve-month performance of the portfolio since inception.
Total Expense Ratio (TER) :	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.
Transaction Costs (TC) :	Is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.
Total Investment Charges (TIC) :	Should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager.
Total Investment Charges (TIC%) :	= TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
Standard Deviation :	The deviation of the return of the portfolio relative to its average.
Drawdown :	The greatest peak to trough loss until a new peak is reached.
Sharpe Ratio :	The ratio of excess return over the risk-free rate divided by the total volatility of the portfolio.
Sortino Ratio :	The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.
Correlation :	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
Value at Risk (VaR) :	Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.
Leverage/Gearing :	The use of securities, including derivative instruments, short positions or borrowed capital to increase the exposure beyond the capital employed to an investment.

Leverage Risk :	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
Derivative Risk :	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.
Counterparty Credit Risk :	Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.
Volatility Risk :	Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.
Concentration and Sector Risk :	A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.
Correlation Risk :	A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include equity pairs trading, fixed income curve trading and commodities pairs trading.
Equity Risk :	Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market price of shares. Equity risk can either be systematic risk which is risk to the entire market based on political and economic indicators or unsystematic risk which is company specific and includes risk relating to company profits, future prospects and general consensus on the company or sector.

Portfolios are valued monthly. The cut off time for processing investment subscriptions is 10:00am on the last business day of the month prior to enable processing for investment on the first business day of the next month. Redemptions are subject to one calendar months notice.
