

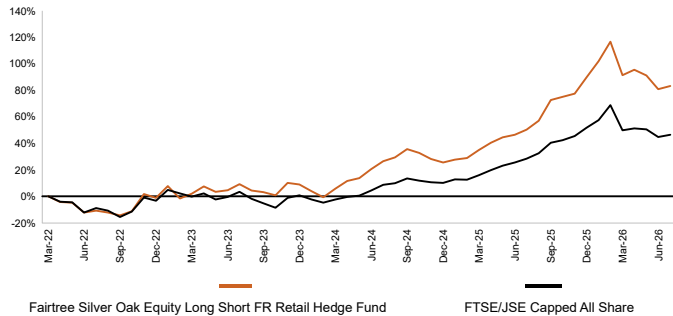
Investment Objective

The objective of the fund is to create long-term wealth for investors by extracting alpha from equity markets.

Fund Profile

The portfolio is managed as a long/short hedge fund, focused on extracting beta and alpha returns from the South African equity market. The funds returns are delivered through fundamental knowledge of South African equities vis-à-vis economic growth and broad economic themes as well as medium to long -term relative valuation opportunities, generating the largest portion of its returns through its directional bias. Relative value pairs, together with absolute longs and shorts seek to stabilize returns in turbulent market conditions, supported by the adjustment to the net exposure.

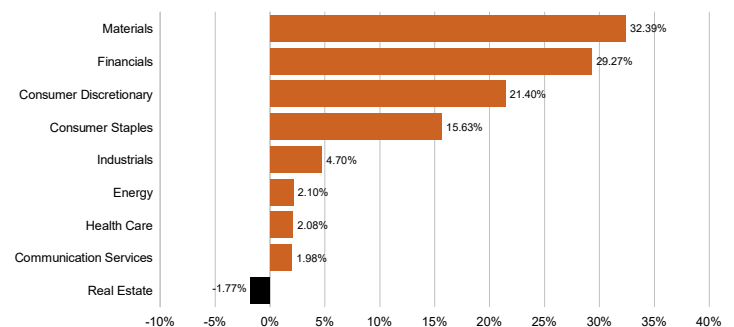

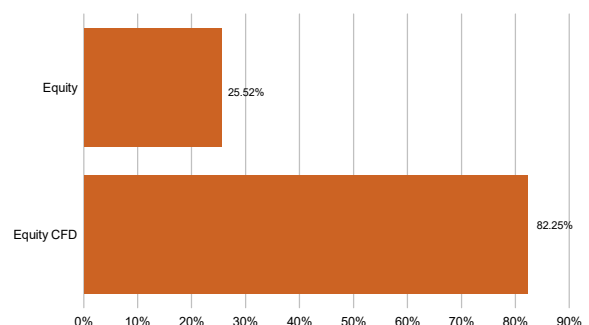

Market Commentary

The biggest global market story in July was the sharp unwinding of the chip and AI trade. The KOSPI fell 22.2%, its worst month since 2008, while US semiconductors had their worst month since 2002. The Nasdaq Composite fell 3.2%, and the S&P 500 was broadly flat despite a strong second-quarter earnings season. The rotation favoured value- and energy-heavy markets, with the UK and Europe outperforming. MSCI Emerging Markets fell 3.1% in US dollars.

The other major event was the FOMC meeting on 29 July. The Fed left rates unchanged at 3.50%-3.75%, with three members voting for a 25bp hike. Chair Warsh provided little guidance and struggled to reconcile his commitment to price stability with the decision not to raise rates. The US two-year yield rose 12bp to 4.29%, the ten-year rose 27bp to 4.74% and the 30-year ended at 5.27%, its highest level since 2007.

The US-Iran conflict remained the key geopolitical risk. The Strait of Hormuz remained effectively closed, while Iran and its proxies broadened their attacks across the region. The Houthis targeted Saudi-linked shipping and declared a blockade on Saudi vessels passing through Bab el-Mandeb. The month ended with Trump suspending a planned escalation as negotiations continued.

Brent rose 24% to end July near US\$90/bbl, having traded above US\$100 during the month. Gold was flat at approximately US\$4,027/oz, while platinum gained 3.7% and copper rose approximately 5%.

In South Africa, June inflation rose to a two-year high of 5.0%, driven by a 34.3% increase in fuel prices. Core inflation rose to 4.1%. Despite this, the SARB surprised the market by holding the repo rate at 7.0%. The decision was split 4-2, with two members favouring a 25bp hike.

The Capped All Share Index gained 1.2%, outperforming bonds, with the ALBI down 1.4%. Resources rose 2.1%, financials 1.2% and industrials 0.3%. Sasol gained 20.2% and Valterra 12.1%, while telecommunications and food producers fell approximately 7%. In US dollars, MSCI South Africa fell 0.4%, underperforming MSCI World (+0.5%) but outperforming MSCI Emerging Markets (-3.1%). The rand weakened towards R17.00/USD before recovering to end the month near R16.50/USD.

The Silver Oak fund outperformed its Capped All Share benchmark by 0.24% during July. The largest contributors to outperformance were long positions in Sasol (+0.9% outperformance), Naspers/Prosus (+0.5%), Glencore (+0.3%), SBOil (+0.2%). Short positions in paper detracted, as did a short position in a telecommunications company and a long position in a food producer.

Glossary

Net Asset Value (NAV) :	Means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.
Annualised Return :	Is the weighted average compound growth rate over the performance period measured.
Highest & Lowest Return :	The highest and lowest rolling twelve-month performance of the portfolio since inception.
Total Expense Ratio (TER) :	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.
Transaction Costs (TC) :	Is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.
Total Investment Charges (TIC) :	Should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager.
Total Investment Charges (TIC%) :	= TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
Standard Deviation :	The deviation of the return of the portfolio relative to its average.
Drawdown :	The greatest peak to trough loss until a new peak is reached.
Sharpe Ratio :	The ratio of excess return over the risk-free rate divided by the total volatility of the portfolio.
Sortino Ratio :	The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.
Correlation :	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
Value at Risk (VaR) :	Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.
Leverage/Gearing :	The use of securities, including derivative instruments, short positions or borrowed capital to increase the exposure beyond the capital employed to an investment.

Leverage Risk :	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
Derivative Risk :	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.
Counterparty Credit Risk :	Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.
Volatility Risk :	Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.
Concentration and Sector Risk :	A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.
Correlation Risk :	A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include equity pairs trading, fixed income curve trading and commodities pairs trading.
Equity Risk :	Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market price of shares. Equity risk can either be systematic risk which is risk to the entire market based on political and economic indicators or unsystematic risk which is company specific and includes risk relating to company profits, future prospects and general consensus on the company or sector.
