What is the purpose of this update?

This document tells you how the Dimensional Global Sustainability PIE Fund (NZD Hedged) has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund


Objective: The investment objective of the fund is to provide long-term capital growth by gaining exposure to a diversified portfolio of securities associated with approved developed markets (excluding Australia), with increased emphasis on higher expected return securities. The fund also considers non-financial factors to target sustainability goals. The fund has a Carbon Footprint Reduction Goal and evaluates companies based on specific sustainability criteria. The fund mitigates currency risk by hedging most major foreign currency exposures to the New Zealand dollar.

Strategy: The fund is expected to be fully invested. The fund is not managed with the objective of achieving a particular return relative to a benchmark index. However, to compare the performance of the fund with a broad measure of market performance, reference may be made to the MSCI World ex Australia Index (net div., hedged to NZD).

What are the risks of investing?

Risk indicator for the Dimensional Global Sustainability PIE Fund (NZD Hedged)¹.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor³


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund when the fund received its first contribution, on 23 June 2022, and did not make any further contributions. At the end of the period to 30 September 2022 Anthony incurred a loss after fund charges were deducted of \$370 (that is -3.70% of his initial \$10,000). This gives Anthony a total loss after tax of \$404 for the period.

This shows the types of assets that the fund invests in.


Actual investment mix

Notes

¹ A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 30 June 2022 and fund returns thereafter.

² As the fund only started accepting contributions on 23 June 2022, historical fee information is not available.
