How has the fund performed?

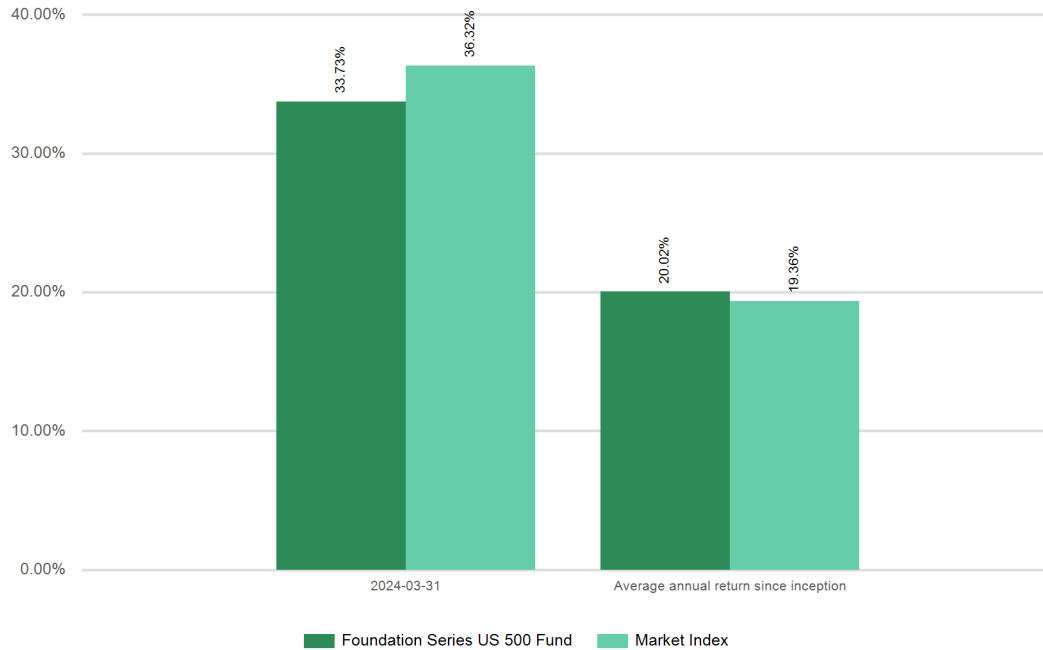

What fees are investors charged?

Investors in the Foundation Series US 500 Fund are charged fund charges. In the year to 31 March 2024 these were:

The charges outlined above represent the fees charged within the ETFs (external management fees) and have been estimated based on information in the ETFs' disclosure documents. Note that the fees within the ETFs are not tax deductible. Investors are charged each time they buy (entry fee) or sell (exit fee) units in the fund. These fees are charged to cover the costs of the underlying brokerage, foreign currency exchange, transaction fees and investment management service fees associated with investing in the underlying investments. Current entry and exit fees are 0.50%.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

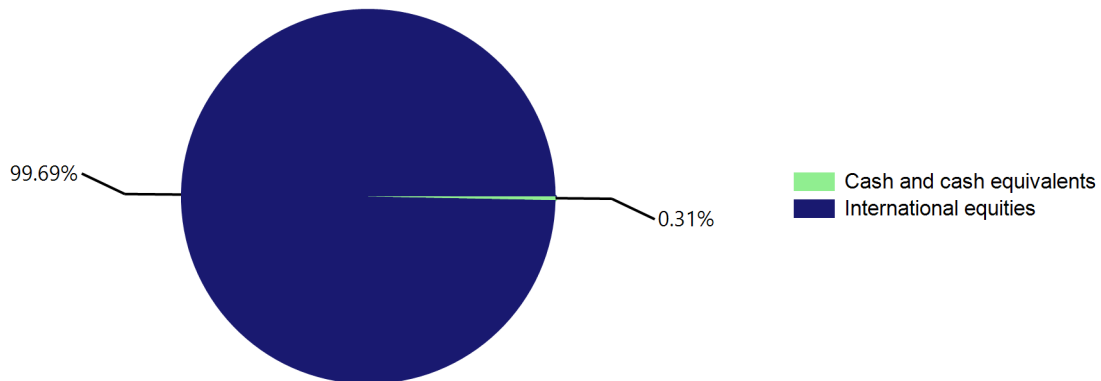
Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$2,874 (that is 28.74% of his initial \$10,000). This gives Anthony a return after tax of \$2,693 for the year.



What does the fund invest in?

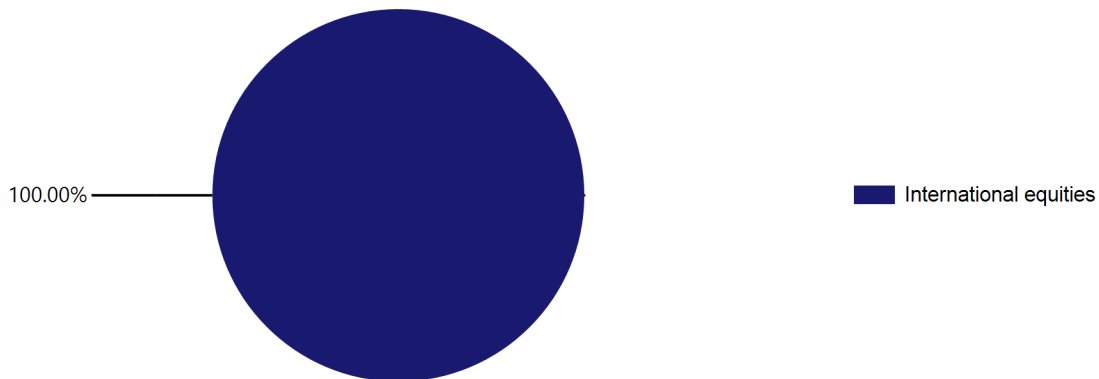
This shows the types of assets that the fund invests in.

Notes
