Fund Objective

To provide a total return, before costs and tax, higher than the S&P/NZX 50 Index (gross and including imputation credits) over the long term (3 years plus).

Fund Update

Stock selection within the healthcare space detracted from performance over the period; notably an underweight to Fisher & Paykel Healthcare and an overweight to Ryman Healthcare. Stock selection amongst utilities also weighed on returns, including an overweight to Contact Energy. Performance was further impacted by an underweight to the communication services space, which outperformed the broader market in April. In contrast, the Fund benefited from an underweight to the poor-performing materials sector; namely an underweight to the sector's sole constituent Vulcan Steel. The Fund also benefited from an underweight to the consumer discretionary space, including names like SkyCity Entertainment Group and Hallenstein Glasson Holdings.
