# **Fund Objective**

To provide a total return, before costs and tax, higher than the S&P/NZX 50 Index (gross and including imputation credits) over the long term (3 years plus).

### **Fund Update**

Stock selection amongst industrials detracted from performance over the period; notably an overweight to Mainfreight, which fell more than 10% in July. Overweights to Freightways and Napier Port Holdings also weighed on returns. Performance was further impacted by stock selection within the consumer staples space. This included an overweight to diversified agribusiness Scales Corp. and an ex-benchmark holding in Foley Wines. An underweight to the strong-performing real estate sector also detracted from returns, albeit modestly. In contrast, the Fund benefited from an overweight exposure and stock selection within the healthcare space; notably overweights to Ryman Healthcare and EBOS Group. Stock selection amongst financials also added value, including an overweight to Infratil, which climbed almost 10% over the period. An underweight to utilities added further, albeit modest value. The utilities sector underperformed the broader market in July.
