#### Fund Profile

The Protea International Hedge Fund SICAV plc ("Fund") is organised under the laws of Malta as a multi class public limited liability company with variable share capital (SICAV) pursuant to the Companies Act (Chapter 386 of the Laws of Malta). The Fund is licensed by the Malta Financial Services Authority ("MFSA") to carry out the activities of a collective investment scheme in the form of a professional investor fund targeting qualifying investors, with registration number SV576 and registered address at 36, Manoel de Vilhena Street, Gzira GZR1012, Malta. The Fund is approved by the Financial Sector Conduct Authority ("FSCA") in South Africa under Section 65 of the Collective Investment Scheme Control Act 2002 and has been categorised as a Collective Investment Scheme for public sale in South Africa. The investment manager systematically identifies individual mispriced securities whilst ensuring sufficient diversification to guard against inappropriate risk concentration. The fund focuses on developed market listed equities worldwide without any limitation to equities of a particular market sector, region, industry of market capitalization, with a maximum gross exposure limit of 400% (i.e. maximum 4x leverage).

#### Investment Strategy

The portfolio is managed as a long/short hedge fund. Its core strategy is to be long undervalued equities and short overvalued equities whilst ensuring that there is sufficient diversification to guard against inappropriate risk concentration. The equities are selected by following a "quantamental" investment approach, which combines traditional fundamental analysis with quantitative investment techniques.



#### Market Commentary

The respective May net returns for the three Non-Institutional share classes of the fund were +5.7% in US Dollars (USD), +6.1% in Euros (EUR), and +4.9% in British Pounds (GBP). The FTSE Developed World Index, on a total return basis net of dividend tax, returned +5.9% in USD, +5.9% in EUR, and +5.0% in GBP for the month.

In terms of sub-strategy attribution for the month, Longs contributed +7.7% while Shorts detracted -2.0%. Special Situations detracted fractionally and Futures & Options made no contribution for the month. Currency translation accounted for the balance of the impact on the fund's reported returns.

Longs listed in the USA, Great Britain, the Eurozone, Switzerland, Denmark, Norway, Hong Kong, Japan, and in Australia contributed positively for the month. Longs listed in Canada, Sweden, and Singapore detracted from May's performance. Our top three Longs for the month were a US buy-now-pay-later operator, a French leisure vehicle manufacturer, and a global social media group. Our three worst-performing Longs for the month were a US health insurer, a Chinese e-commerce group, and a UK-listed fintech group.

Shorts listed in Denmark contributed positively for the month. Shorts in the US, Great Britain, the Eurozone, Switzerland, Norway, and in Sweden detracted from the fund's May return. Our top three Shorts for the month were a US autonomous vehicle company, a Danish medical equipment manufacturer, and a Spanish telecommunication infrastructure group. Our three worst-performing Shorts for the month were a themed exchange-traded fund, a US power utility, and an electric vehicle company.

Special Situations made a fractionally negative contribution. We did not trade any Future & Option instruments during the month. The fund now holds cash in various currencies rather than just in USD (which was the case up to April). This results in some profit or loss movements due to the translation of cash from the various currencies to the reporting currency. We are comfortable with moving away from holding all cash in USD to rather holding cash in a basket of currencies.

We continue to manage the fund prudently, with a long-term focus.

Fund Risk	
Leverage Risk:	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
Derivative Risk:	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.
Counterparty Credit Risk:	Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.
Volatility Risk:	Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.
Concentration and Sector Risk:	A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.
Correlation Risk:	A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include equity pairs trading, fixed income curve trading and commodities pairs trading.
Equity Risk:	Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market price of shares. Equity risk can either be systematic risk which is risk to the entire market based on political and economic indicators or unsystematic risk which is company specific and includes risk relating to company profits, future prospects and general consensus on the company or sector.
Currency/Exchange Rate Risk:	Assets of a fund may be denominated in a currency other than the Base Currency of the fund and changes in the exchange rate between

Net Asset Value (NAV):	Means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.
Annualised Return:	Is the weighted average compound growth rate over the performance period measured.
Highest & Lowest Return:	The highest and lowest rolling twelve-month performance of the portfolio since inception.
Total Expense Ratio (TER):	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.

Total Investment Charges (TIC%):	= TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
Leverage/Gearing:	The use of securities, including derivative instruments, short positions or borrowed capital to increase the exposure beyond the capital employed to an investment.
Alpha:	Denoted the outperformance of the fund over the benchmark.
Sharpe Ratio:	The ratio of excess return over the risk-free rate divided by the total volatility of the portfolio.
Sortino Ratio:	The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.
Standard Deviation:	The deviation of the return of the portfolio relative to its average.
Drawdown:	The greatest peak to trough loss until a new peak is reached.
Correlation:	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
Value at Risk (VaR):	Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.
