We identified incorrect fund charges have been used. These have been corrected and have resulted in a change to the "What fees are investors charged?" section in this fund update.

What is the purpose of this update?

This document tells you how the Aurora RetirementPlus Age 75 has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Strategy: This investment option invests 15% in the Aurora Growth Fund and 85% in the Aurora Conservative Fund.



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$566 (that is 5.66% of his initial \$10,000). Antony also paid \$36 in other charges. This gives Anthony a return after tax of \$429 for the year.


Actual Investment Mix
