What is the purpose of this update?

This document tells you how the Foundation Series Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: To perform broadly in line with the return of its investment benchmark before fees and tax over the long-term. The long-term returns from the Foundation Series Growth Fund are likely to be higher and less stable than those of the Foundation Series Balanced Fund.

Strategy: Aims for high long-run returns by investing in a diversified portfolio weighted towards growth assets but with some income asset exposure.

How has the fund performed?



Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,091 (that is 10.91% of his initial \$10,000). This gives Anthony a return after tax of \$980 for the year.

This shows the types of assets that the fund invests in.


Actual Investment Mix



Foreign currency was not hedged to New Zealand dollars as at 30 June 2025

The fund has foreign currency exposure and targets currency positions being fully hedged on international fixed interest assets and 50% hedged on international equity assets.

Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. Market index returns have been used until 30 September 2020 and fund returns thereafter. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.
- Underlying fund fees and expenses are reflected in the unit prices of the underlying funds that are used when calculating the unit price of the fund. Estimates of these fees and expenses have been made based on information provided by underlying fund managers of each underlying fund's actual costs as a percentage of the average net asset value that was charged, for each underlying fund's previous financial year.
- 3. The top 10 assets may add up to more than 100% of NAV as the fund also has liabilities which offsets these assets.
- 4. The bar chart shows fund returns after deducting fees and tax. Tax is deduced at the highest Prescribed Investor Rate of 28%. However, the market index returns are shown before deducting fees and tax.
