## Fund Objective

To provide a total return, before costs and tax, higher than the S&P Global Listed Infrastructure Index NZD Hedged (Net TR) over the long term. The Fund targets a 20% carbon footprint reduction relative to its market index.

## Fund Update

Stock selection within the airports sector contributed positively to performance over the period, including an underweight to Auckland International Airport and our holdings in Mexico's Grupo Aeroportuario del Sureste S.A.B. de C.V. and Grupo Aeroportuario del Pacífico S.A.B. de C.V. An ex-benchmark exposure to communication services also added value; notably our holdings in Infrastrutture Wireless Italiane S.p.A. and Spain's Cellnex Telecom SA. In contrast, stock selection within the energy space detracted from overall performance. This included overweights to US names ONEOK, Targa Resources and Cheniere Energy. Stock selection amongst electric utilities also weighed on returns, including an underweight to US provider Constellation Energy and our holdings in country peers Xcel Energy and Entergy Corp.
