## Fund Objective

To provide a total return, before costs and tax, higher than the S&P Global Listed Infrastructure Index NZD Hedged (Net TR) over the long term. The Fund targets a 20% carbon footprint reduction relative to its market index.

## Fund Update

Stock selection amongst electric utilities detracted from performance over the period; notably underweights to US names Constellation Energy and NextEra Energy. Stock selection within the multi utilities space also weighed on returns, including our holdings in CenterPoint Energy and Ameren Corp. Performance was further impacted by stock selection within the transportation infrastructure sector; notably airports. This included underweights to strong-performing Mexican names like Grupo Aeroportuario del Pacífico, S.A.B. de C.V. and Grupo Aeroportuario del Centro Norte, S.A.B. de C.V. In contrast, the Fund benefited from an underweight to the energy space; the sector underperforming the broader market over the period. In terms of strategic factor positioning, our underweight to size added value in May, with small caps outperforming their larger counterparts over the period.
