### **Fund Objective**

To provide a total return, before costs and tax, higher than the S&P Global Listed Infrastructure Index NZD Hedged (Net TR) over the long term. The Fund targets a 20% carbon footprint reduction relative to its market index.

### **Fund Update**

Stock selection within the electric utilities sector detracted from performance; notably an underweight to US name Constellation Energy, which returned more than 60% for the quarter. Other positions to impact returns were our holdings in country peers Xcel Energy and Entergy Corp. Stock selection amongst multi utilities also weighed on returns, including an underweight to France's Engie SA. Performance was further impacted by stock selection within the energy space. This included overweights to US majors ONEOK and Targa Resources. In terms of strategic factor positioning, our underweight to size had a negative impact on returns, with small caps underperforming their larger counterparts over the period. In contrast, the Fund benefited from an ex-benchmark exposure to the information technology space, albeit modestly. This included our holding in Australian data centre owner NextDC, which climbed almost 30% for the quarter.
