## Fund Objective

To provide a total return, before costs and tax, higher than the S&P Global Listed Infrastructure Index NZD Hedged (Net TR) over the long term. The Fund targets a 20% carbon footprint reduction relative to its market index.

## Fund Update

The underweight allocation to Electric Utilities detracted from performance. The off-benchmark allocation to Waste also had a negative impact on performance. However, the underweight allocation, along with favorable security selection within Midstream Energy, contributed positively to performance.

The Performance calculation is measured as Net income generated over the period inclusive of fees and tax. Tax is calculated applying a PIR of 28% on taxable income. Net fund performance shown is net of fees and charges. Assumes reinvestment of income.
