What is the purpose of this update?

This document tells you how the Vision Invest NZ Retail Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: To generate returns (after fees but before tax) that are above the median 1-year gross term deposit rate paid by the registered New Zealand banks.

Strategy: The Fund is intended to provide members of the Brethren community (Community) with an investment product that suitably satisfies the Community's ethical requirements, as an alternative to other fixed income investments in the market. The investment Manager will set a rate of return at which distributions to investors will be paid. Where the Fund's net income exceeds that set rate, the excess will be paid to Vision Invest Trust (Residual).



How has the fund performed?

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$541 (that is 5.41% of his initial \$10,000). This gives Anthony a total return after tax of \$387 for the year.


What does the fund invest in?

Returns from the Sovereign Capital Trust (a New Zealand wholesale unit trust which invests in a similar way to that proposed by the fund) have been used to calculate the risk indicator for the period 30 June 2020 and fund returns thereafter. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.
