The Fund mitigates currency risk by hedging most major foreign currency exposures to the New Zealand dollar.

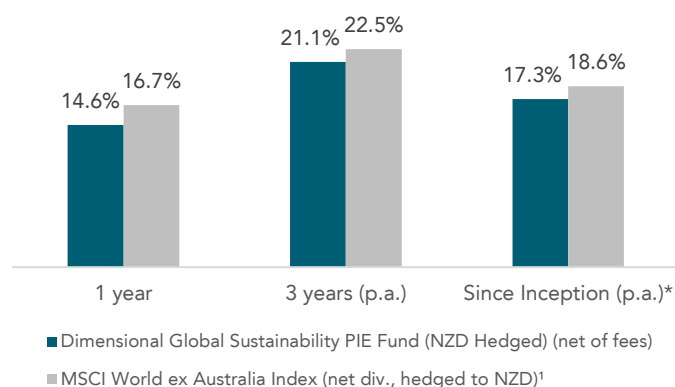
