What is the purpose of this update?

This document tells you how the Trust Management ESG Australasian Share Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

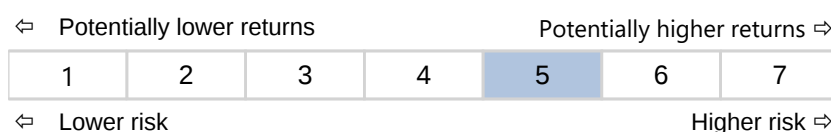
Objective: To generate a total return that exceeds the return of the S&P/NZX50 Portfolio Gross Index over rolling three-year periods, before taking into account fees and expenses.

Strategy: To provide a diversified exposure to New Zealand and Australian equities that meet certain ethical investment criteria. The Fund targets a position of being close to 100% hedged to NZ dollars on its Australian dollar exposures.

What are the risks of investing?

Risk indicator for the Trust Management ESG Australasian Share Fund.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

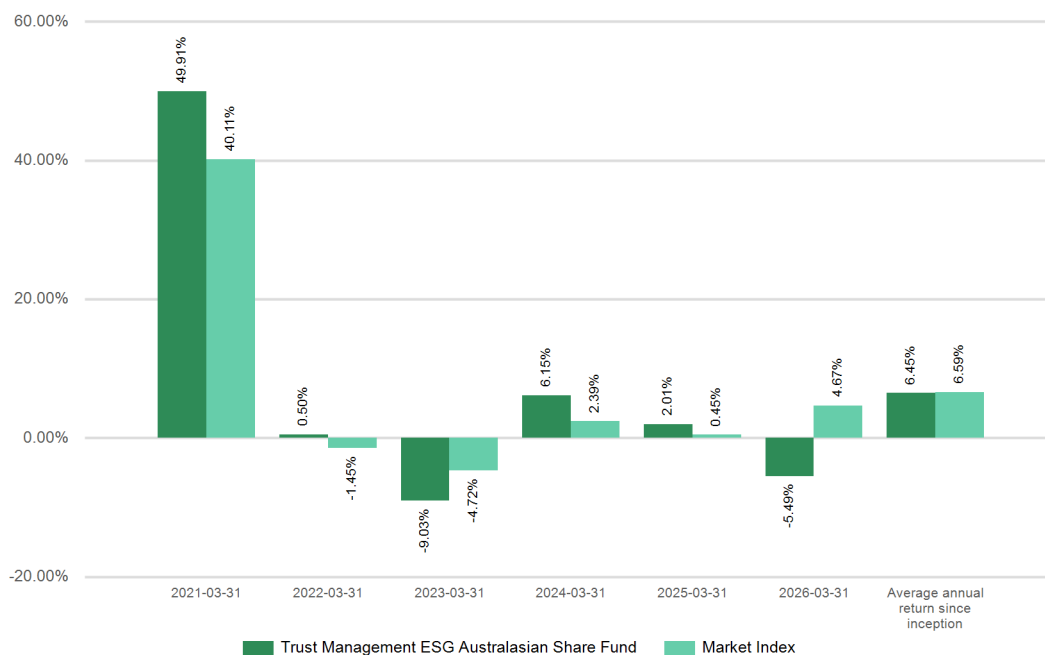
How has the fund performed?

Example of how this applies to an investor

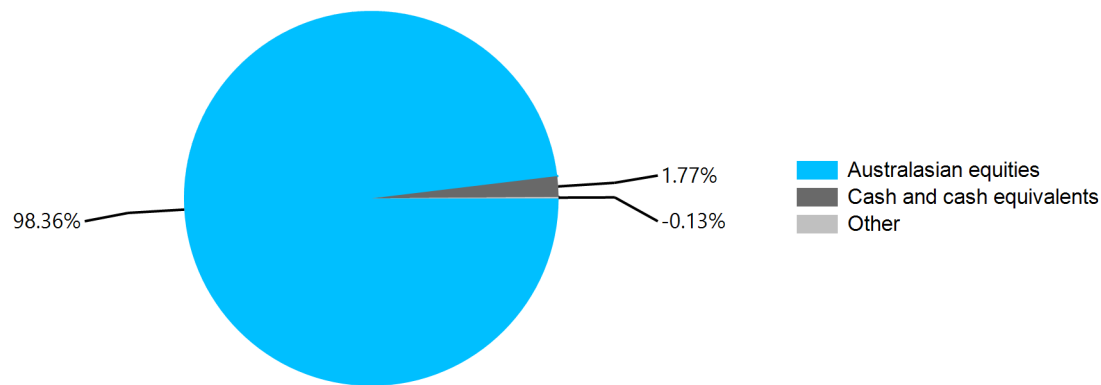
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony incurred a loss after fund charges were deducted of \$322 (that is -3.22% of his initial \$10,000). This gives Anthony a loss after tax of \$314 for the year.

What does the fund invest in?

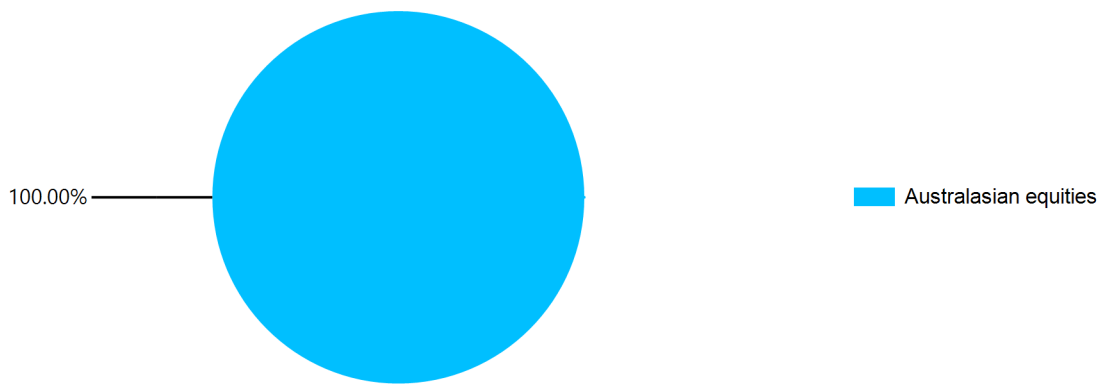
This shows the types of assets that the fund invests in.
