Fund Update

In April, we restructured the Russell Investments New Zealand Fixed Interest Fund; removing Western Asset Management and Harbour Asset Management from the Fund's manager line up and replacing them with an internal, model-driven investment strategy. This strategy is designed to deliver excess returns over the Fund's existing benchmark, i.e. the Bloomberg NZ Bond Composite 0+ Year Index. The strategy's investment guidelines are similar to those applied to the previous mandates, which will ensure consistency with the Fund's existing risk profile. The strategy has yet to complete a full month of performance.
