What is the purpose of this update?

This document tells you how the Foundation Series Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: To perform broadly in line with the return of its investment benchmark before fees and tax over the long-term.

Strategy: Aims for high long-run returns by investing in a diversified portfolio weighted towards growth assets but with some income asset exposure.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,213 (that is 12.13% of his initial \$10,000). This gives Anthony a total return after tax of \$1,125 for the year.

What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes

- 1 A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 30 September 2020 and fund returns thereafter.
- 2 Underlying fund fees and expenses are reflected in the unit prices of the underlying funds that are used when calculating the unit price of the fund. Estimates of these fees and expenses have been made based on information provided by underlying fund managers of each underlying fund's actual costs as a percentage of the average net asset value that was charged, for each underlying fund's previous financial year.
