Fund Profile

The Protea International Hedge Fund SICAV plc ("Fund") is organised under the laws of Malta as a multi class public limited liability company with variable share capital (SICAV) pursuant to the Companies Act (Chapter 386 of the Laws of Malta). The Fund is licensed by the Malta Financial Services Authority ("MFSA") to carry out the activities of a collective investment scheme in the form of a professional investor fund targeting qualifying investors, with registration number SV576 and registered address at 36, Manoel de Vilhena Street, Gzira GZR1012, Malta. The Fund is approved by the Financial Sector Conduct Authority ("FSCA") in South Africa under Section 65 of the Collective Investment Scheme Control Act 2002 and has been categorised as a Collective Investment Scheme for public sale in South Africa. The investment manager systematically identifies individual mispriced securities whilst ensuring sufficient diversification to guard against inappropriate risk concentration. The fund focuses on developed market listed equities worldwide without any limitation to equities of a particular market sector, region, industry of market capitalization, with a maximum gross exposure limit of 400% (i.e. maximum 4x leverage).

Investment Strategy

The portfolio is managed as a long/short hedge fund. Its core strategy is to be long undervalued equities and short overvalued equities whilst ensuring that there is sufficient diversification to guard against inappropriate risk concentration. The equities are selected by following a "quantamental" investment approach, which combines traditional fundamental analysis with quantitative investment techniques.



Market Commentary

The respective April net returns for the three Non-Institutional share classes of the fund were +0.7% in US Dollars (USD), -4.1% in Euros (EUR), and -2.6% in British Pounds (GBP). The FTSE Developed World Index, on a total return basis net of dividend tax, returned +1.0% in USD, -3.8% in EUR, and -2.3% in GBP for the month. Equity, debt and currency markets all experienced a volatile April as the tariff war was ignited on 'liberation' day.

In terms of sub-strategy attribution for the month, Longs contributed +4.7% while Shorts detracted -2.5%. Special Situations chipped in +0.1%, and Futures & Options made no contribution for the month. Currency translation accounted for the balance of the impact on the fund's reported returns. During the month, the equity derivatives held by the fund changed from settlement in USD to settlement in the underlying currency of the respective equities. This allows us more flexibility in terms of the preferred currency exposure of the fund, rather than needing to hold the vast majority of the fund's cash in USD, which has been the case to-date.

Longs listed in Canada, the USA, Great Britain, Switzerland, Norway, Japan, and in Australia contributed positively for the month. Longs listed in the Eurozone, Denmark, Sweden, Singapore, and in Hong Kong detracted from April's performance. Our top three Longs for the month were two emerging market banks and a US buy-now-pay-later operator. Our three worst-performing Longs for the month were two Chinese e-commerce groups and a US health insurer.

Shorts listed in Great Britain, Switzerland, Denmark, and in Norway contributed positively for the month. Shorts in the US, the Eurozone, and in Sweden detracted from the fund's April return. Our top three Shorts for the month were a US chemicals group, a Norwegian semiconductor designer, and a global real estate investment trust. Our three worst-performing Shorts for the month were a Swiss real estate investment trust, a themed exchange-traded fund, and an autonomous vehicle company.

Special Situations made a marginally positive contribution on the back of a structural market inefficiency which we identified, potentially leading to additional similar trades. We did not trade any Future & Option instruments during the month. Currency translation detracted from the fund's returns reported in EUR and in GBP for April, due to the sharp weakening of the USD. There was an additional negative contribution from Currency this month due to the derivative settlement currency change.

We continue to manage the fund prudently, with a long-term focus.

Leverage Risk:	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
Derivative Risk:	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.
Counterparty Credit Risk:	Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.

Sortino Ratio:	The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.
Standard Deviation:	The deviation of the return of the portfolio relative to its average.
Drawdown:	The greatest peak to trough loss until a new peak is reached.
Correlation:	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
