What is the purpose of this update?

This document tells you how the Brandywine Global Opportunistic Fixed Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: To earn a return before fees and taxes in excess of the Bloomberg Global Aggregate Index -New Zealand dollar Hedged over rolling five-year periods.

Strategy: The fund invests in an actively managed portfolio of sovereign bonds, investment grade corporate bonds, mortgage securities, currencies, and other similar securities. The fund can also invest in emerging market debt, high yield debt, and below investment grade non-sovereign and corporate debt.

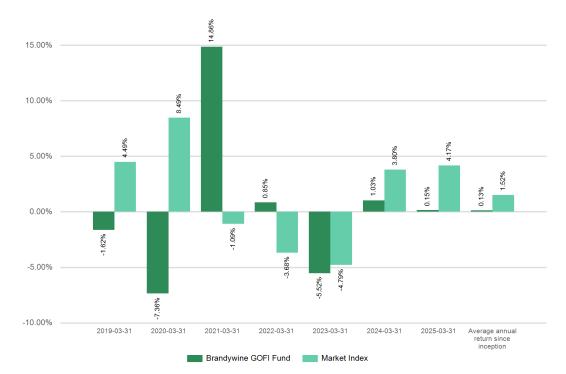

On 1 April 2022, the market index for the fund changed from the FTSE World Government Bond Index (100% Hedged to New Zealand Dollars) to the Bloomberg Global Aggregate Index - New Zealand dollar Hedged. Returns of the FTSE World Government Bond Index (100% Hedged to New Zealand Dollars) have been used until 31 March 2022 and the Bloomberg Global Aggregate Index (New Zealand dollar Hedged) returns thereafter to calculate returns of the market index.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

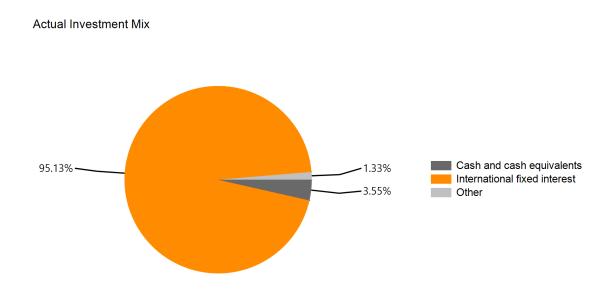
Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$17 (that is 0.17% of his initial \$10,000). This gives Anthony a return after tax of \$15 for the year.



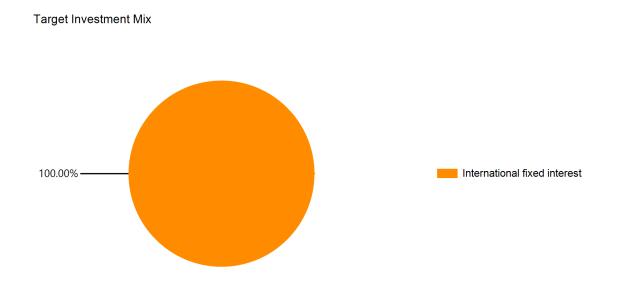


What does the fund invest in?
