What is the purpose of this update?

Strategy: This investment option invests 15% in the Aurora Growth Fund and 85% in the Aurora Conservative Fund.

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$512 (that is 5.12% of his initial \$10,000). Antony also paid \$36 in other charges. This gives Anthony a return after tax of \$367 for the year.


What does the fund invest in?
