

About the Fund

The Fund aims to achieve long-term capital growth through a diversified portfolio of mainly growth assets, with a small proportion to income assets. The portfolio is actively managed and includes Australasian equities and international equities, infrastructure, fixed interest, and cash. The Fund is biased to investments that target a low-carbon economy and can contribute to a more sustainable future.

FUND OBJECTIVE

To deliver returns exceeding the CPI by 4.00% per annum before fees and tax, over a suggested investment timeframe of 10+ years.

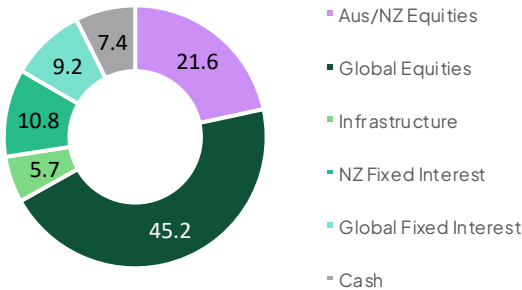

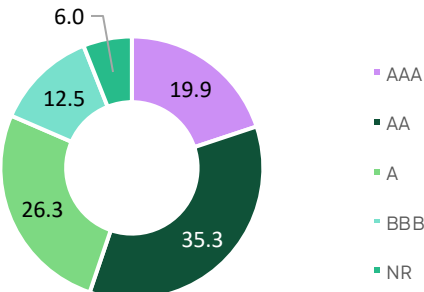

Climate and environmental metrics

We monitor the climate impact of the investment in the portfolio through carbon metrics, such as the temperature alignment. We also monitor how much of the portfolio is aligned with the UN’s Sustainable Development Goals (SDGs), based on annual sales of the underlying companies. We prioritise the 4 SDGs that we regard as the most relevant to the climate and environment. These metrics are applied on the equity and listed infrastructure component of the portfolio.
