### ESG NZ Bond Fund

#### Fund Update for the quarter ended 30 June 2025

This fund update was first made publicly available on 28 July 2025.

#### What is the purpose of this update?

This document tells you how the Trust Management - ESG NZ Bond Fund has performed and what fees were charged. The document will help you to compare the Fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Fund provides a diversified exposure to New Zealand fixed-interest securities that meet certain ethical investment criteria.

The investment objective of the Fund is generate a total return that exceeds the return of the Bloomberg NZBond Composite 0+ Year Index over rolling three year periods, before taking into account fees and expenses.

#### What are the risks of investing?

Risk indicator for the Trust Management - ESG NZ Bond Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.

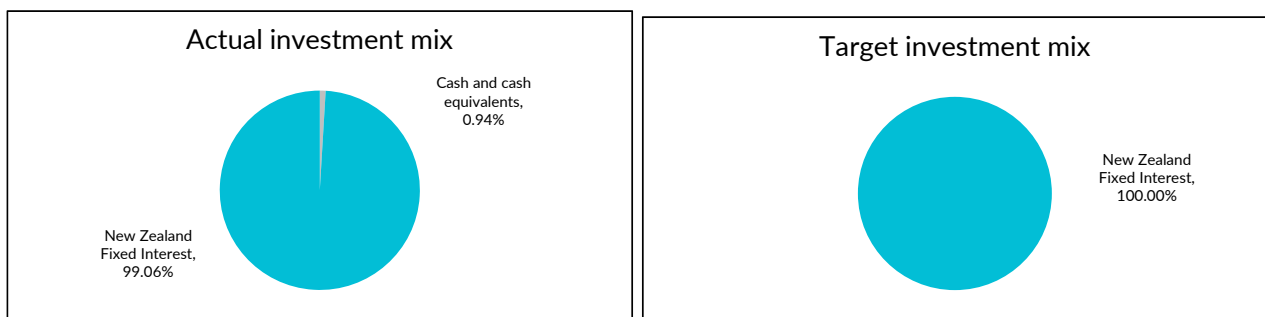
### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

The Smith Charitable Trust had \$100,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, the Smith Charitable Trust received a return after fund charges were deducted of \$7,170 (that is 7.17% of the initial \$100,000). This gives the Smith Charitable Trust a total return after tax of \$5,130.
