Notification To Investors

Changes to MI Canaccord Genuity Investment Funds (the “Company”) and its Funds (the “Funds”)

Dear Investor,

We, Apex Fundrock Ltd, as Authorised Corporate Director (the “ACD”) of the Company, are writing to you as an investor of the Company, to inform you of certain upcoming changes to the Company and each of the Funds.

Although you do not need to take any action, please take the time to read this letter carefully as it provides you with important information about the Fund in which you are invested.

The changes outlined below will take effect from 10th August 2026 (the “Effective Date”), unless otherwise stated.

Change of name of the Company

On the Effective Date, the ACD will change the name of the Company from “MI Canaccord Genuity Investment Funds” to “MI Canaccord Wealth Investment Funds”. The reason for this change is the Investment Manager undertook a corporate rebranding exercise, changing its trading name from Canaccord Genuity Wealth Management to Canaccord Wealth. This rebrand formed part of a strategic initiative to streamline the firm's identity, enhance the clarity of its market positioning, and establish a more cohesive and distinctive brand presence within the UK wealth management sector. To ensure alignment with the updated corporate identity and to maintain consistency across all client facing materials, it is proposed that the funds be renamed to reflect the new Canaccord Wealth branding.

Change of name of the existing Funds of the Company

The ACD is changing the name of the Funds of the Company for the same reasons as given above. A detailed list of the changes can be found in the Appendix to this letter.

To confirm; these changes relate solely to the nomenclature of the Company and the Funds, and will not alter the investment objective and policy, management or charges.

FCA confirmation

The Financial Conduct Authority (“FCA”) has confirmed by letter to Eversheds Sutherland (International) LLP, solicitors to the ACD, that the changes outlined above will not affect the authorisation of the Company under regulations 21 of the Open-Ended Investment Companies Regulations 2001.

Costs

All associated costs in connection with this proposed change will be borne by Canaccord Genuity Investment Management.
