What is the purpose of this update?

This document tells you how the Coolabah Long-Short Credit PIE Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: The fund targets investment returns, after fees and before tax, of 4% to 6% per annum above the overnight interbank cash rate as published by the Reserve Bank of New Zealand, with less than 5% per annum volatility over rolling 3 year periods.

Strategy: The fund provides exposure to an actively managed, absolute return fixed income strategy focused on exploiting long and short mispricings in global credit markets. The fund currently invests in an underlying fund managed by Coolabah Capital Investments (Retail) Pty Limited (Investment Manager) and targets a position of being fully hedged back to New Zealand dollars.



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,600 (that is 16.00% of his initial \$10,000). This gives Anthony a total return after tax of \$1,365 for the year.

This shows the types of assets that the fund invests in.


Actual investment mix 3, 4

Notes

- 1 The fund has not been operating for the required five years. The fund invests in an underlying fund which has an established return history. To calculate the risk indicator, underlying fund returns have been used for the period to 31 December 2021 and fund returns thereafter. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.
- 2 The bar chart shows fund returns after deducting fees and tax. Tax is deducted at the highest Prescribed Investor Rate of 28%. However, the market index returns are shown before deducting fees and tax. Your tax may be lower.
- 3 The underlying fund into which the fund invests can take long and short positions, use repurchase agreements, borrow and use derivatives, meaning the underlying fund may be geared (or leveraged). Leverage limits are in place to assist with risk management. The underlying fund may be leveraged up to a maximum of 500% of NAV. The underlying fund may also take short positions up to a maximum of 200% of NAV. The rules are asset-class specific, with riskier exposures subject to tighter controls. Leverage can amplify gains and also amplify losses. These features mean that the fund will not be appropriate for all investors. - 4 International fixed interest are netted off by repurchase agreement, which was -220.88% as at 31 March 2024. Without the repurchase agreement, the total actual % of international fixed interest was 308.24%.
