What is the purpose of this update?

This document tells you how the Russell Investments Hedged Sustainable Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: To provide a total return, before costs and tax, in line with the MSCI ACWI Index – 100% Hedged to NZD – Net over the long term with a focus on reducing the fund's carbon exposure relative to benchmark.

Strategy: The fund invests predominantly in a broad range of international shares listed on stock exchanges in developed and emerging international markets. The fund will maintain a reduced carbon exposure compared to the Benchmark, whilst also increasing exposure to renewable energy and taking into account other ESG considerations such as the exclusion of controversial weapons, firearms, uranium and tobacco companies. Derivatives may be used to obtain or reduce exposure to securities and markets, to implement investment strategies and to manage risk. Foreign currency exposures are largely hedged back to New Zealand dollars.




Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,436 (that is 14.36% of his initial \$10,000). This gives Anthony a total return after tax of \$1,278 for the year.

What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes

- 1 A combination of actual fund returns, and Market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. Market index returns have been used until 31 December 2021 and fund returns thereafter. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.
- 2 The bar chart shows fund returns after deducting fees and tax. Tax is deducted at the highest Prescribed Investor Rate of 28%. However, the market index returns are shown before deducting fees and tax.
