
Investment Objective

The objective of the fund is to create long-term wealth for investors by extracting alpha from equity markets.

Fund Profile

The portfolio is managed as a long/short hedge fund, focused on extracting beta and alpha returns from the South African equity market. The funds returns are delivered through fundamental knowledge of South African equities vis-à-vis economic growth and broad economic themes as well as medium to long -term relative valuation opportunities, generating the largest portion of its returns through its directional bias. Relative value pairs, together with absolute longs and shorts seek to stabilize returns in turbulent market conditions, supported by the adjustment to the net exposure.





Market Commentary

March was marked by significant global economic uncertainty. For the second month in a row, emerging markets and European equities showed strength, while US markets struggled with concerns emerging around policy and growth. The biggest story in March was the back-and-forth tariff policy of the Trump Administration, with US equities falling as tariff threats and actions increased, and rebounding when the policy reversed. Proposed tariffs included a 25% tariff on Canadian and Mexican goods and a 20% tariff on Chinese imports, which contributed to a sharp decline in equities (S&P 500 Index -5.6%, Nasdaq -7.6%). Moreover, the DXY, which had been rallying into tougher tariff announcements (a stronger US dollar would offset some of the higher tariffs), began to sell off into tariff announcements, signalling growing fears of US recession risks. Consumer confidence in the US dropped to its lowest level in four years, reflecting concerns over rising prices and the broader economic outlook. The Federal Reserve held interest rates steady in March, maintaining a cautious stance while projecting a 50-bps rate cut later in the year. However, we believe that there will be more rate cuts than currently priced by the market, as growth is set to slow meaningfully. Fed Chair Jerome Powell noted the committee's readiness to adjust rates if needed but emphasised waiting for clearer insights into the impact of new policies before making further decisions. The combination of weaker US economic data and a less hawkish Fed speech saw bond yields drop towards 4%. In Europe, Germany passed a €1th package of defence and infrastructure spending, pushing European growth european equities higher, with two-year Euro yields up 5 bps to 2.19% and the euro 4.3% stronger.

Commodities rallied, with Gold up US\$266/oz to US\$3124/oz, another new monthly closing high and now up 19% year to date. Copper increased by US\$321/oz to US\$9659/oz, while Palladium jumped by US\$69/oz to US\$991/oz. Brent crude rose US\$3.7/bbl to US\$77.2/bbl as Trump threatened secondary tariff sanctions on buyers of Venezuelan, Iranian and Russian crude oil over the month. The worst-performing commodities were iron ore (-3.1%) and lumber (-2.2%).

In March, the Capped SWIX index rose 3.6%, almost entirely due to a surge in precious metals, with the sector rallying +34% month-to-date. Equity indices outperformed the ALBI (+0.7%), and the rand strengthened by 2.0% to RI8.32 versus the US dollar. Resources (+18.5%) outperformed in March, while financials (+0.2%) and industrials (-0.3%) were basically flat. Key sector leaders were precious metals (+34.3%) and tobacco (+5.0%), with key performing names including AngloGold (+30.5%) and Anglo American Platinum (+30.5%). Laggards included personal goods (-15.1%) and Paper (-11.5%). MSCI South Africa rallied 7.0%, outperforming MSCI World (-4.6%) and MSCI EM (+0.4%) in US dollar terms.

The South African budget, tabled for the second time on 12 March, failed to gain GNU consensus. Negotiations are ongoing, with the DA demanding measures like PRASA devolution and co-chairing Operation Vulindlela to support the ANC on the budget. On 21 March, the MPC kept the key policy rate at 7.5%, as anticipated. The meeting was more balanced than January's hawkish tone, hinting at possible future rate cuts.

The Silver Oak Fund outperformed its Capped SWIX benchmark by 1.1% in March. The largest contributors to outperformance were long positions in the gold equities (AngloGold +1.1%, Goldfields +0.7% outperformance), as well as a long position Anglo American Platinum (+0.6%). A short position in a consumer discretionary company (+1.1%) and a food retailer (+0.4%) also contributed to positive outperformance. Short positions in precious metal miners and a long position in a retailer and diversified miner detracted most from Fund performance in March.

Glossary

Glossaly	
Net Asset Value (NAV) :	Means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.
Annualised Return :	Is the weighted average compound growth rate over the performance period measured.
Highest & Lowest Return :	The highest and lowest rolling twelve-month performance of the portfolio since inception.
Total Expense Ratio (TER) :	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.
Transaction Costs (TC) :	Is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.
Total Investment Charges (TIC) :	Should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager.
Total Investment Charges (TIC%) :	= TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
Standard Deviation :	The deviation of the return of the portfolio relative to its average.
Drawdown :	The greatest peak to trough loss until a new peak is reached.
Sharpe Ratio :	The ratio of excess return over the risk-free rate divided by the total volatility of the portfolio.
Sortino Ratio :	The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.
Correlation :	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
Value at Risk (VaR) :	Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.
Leverage/Gearing :	The use of securities, including derivative instruments, short positions or borrowed capital to increase the exposure beyond the capital employed to an investment.
Fund Risk	
Leverage Risk :	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
Derivative Risk :	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.
Counterparty Credit Risk :	Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.
Volatility Risk :	Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.
Concentration and Sector Risk :	A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.
Correlation Risk :	A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include equity pairs trading, fixed income curve trading and commodities pairs trading.
Equity Risk :	Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market price of shares. Equity risk can either be systematic risk which is risk to the entire market based on political and economic indicators or unsystematic risk which is company specific and includes risk relating to company profits, future prospects and general consensus on the
