How has the fund performed?



Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,918 (that is 19.18% of his initial \$10,000). This gives Anthony a return after tax of \$1,731 for the year.

This shows the types of assets that the fund invests in.


Actual Investment Mix

Notes
