What is the purpose of this update?^{See note 1}

This document tells you how the Aurora RetirementPlus Age 75 has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: RetirementPlus age 75 is a representation of the RetirementPlus life cycle.

Strategy: This investment option invests 15% in the Aurora Growth Fund and 85% in the Aurora Conservative Fund.


How has the fund performed?

(A) This investment option invests 15% in the Aurora Growth Fund and 85% in the Aurora Conservative Fund. The fees are based on how much the investment option invests in each of the funds and how much they charged. (B) "Other management and administration charges" includes an estimate of the charges incurred in the underlying fund in which the Fund invests. The estimate incorporates information provided by the underlying fund manager as well as information sourced from the underlying fund's disclosure documents.

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$550 (that is 5.50% of his initial \$10,000). Anthony also paid \$36 in other charges. This gives Anthony a return after tax of \$419 for the year.

This shows the types of assets that the fund invests in.


Actual Investment Mix

Notes

1. On or about 20 February 2026, Hive Funds Limited will replace FundRock NZ Limited as manager of the fund.
2. A combination of actual returns and market index returns have been used to determine the risk indicator as the investment option has not been operating for the required five years. Market index returns have been used until 31 August 2021 and actual returns thereafter. The risk indicator may therefore provide a less reliable indicator of future volatility.
3. The bar chart shows returns of the investment option after deducting fees and tax. Tax is deducted at the highest Prescribed Investor Rate of 28%. However, the market index returns are shown before deducting fees and tax.
