
🗱 Fund Profile

The Protea International Hedge Fund SICAV plc ("Fund") is organised under the laws of Malta as a multi class public limited liability company with variable share capital (SICAV) pursuant to the Companies Act (Chapter 386 of the Laws of Malta). The Fund is licensed by the Malta Financial Services Authority ("MFSA") to carry out the activities of a collective investment scheme in the form of a professional investor fund targeting gualifying investors, with registration number SV576 and registered address at 36, Manoel de Vilhena Street, Gzira GZR1012, Malta. The Fund is approved by the Financial Sector Conduct Authority ("FSCA") in South Africa under Section 65 of the Collective Investment Scheme Control Act 2002 and has been categorised as a Collective Investment Scheme for public sale in South Africa. The investment manager systematically identifies individual mispriced securities whilst ensuring sufficient diversification to guard against inappropriate risk concentration. The fund focuses on developed market listed equities worldwide without any limitation to equities of a particular market sector, region, industry of market capitalization, with a maximum gross exposure limit of 400% (i.e. maximum 4x leverage).

Investment Strategy

The portfolio is managed as a long/short hedge fund. Its core strategy is to be long undervalued equities and short overvalued equities whilst ensuring that there is sufficient diversification to guard against inappropriate risk concentration. The equities are selected by following a "quantamental" investment approach, which combines traditional fundamental analysis with quantitative investment techniques.




🎇 Portfolio Objective

🎇 Market Commentary

The respective March returns for the three Non-Institutional share classes of the fund were +4.7% in US Dollars (USD), +4.8% in Euros (EUR), and +4.7% in British Pounds (GBP). The MSCI World Index delivered a total return of +3.3% in USD, +3.4% in EUR, and +3.3% in GBP for the month. In terms of our sub-strategies, Longs contributed just over 5% and Shorts broke even. Special Situations and Futures & Options made no contribution, while Currency translation accounted for the balance of the impact on the fund's instrument-level return. For the quarter, the fund returned +9.2% in USD, +12.0% in EUR, and +10.4% in GBP. The MSCI World Index delivered a total return of +8.9% in USD, +11.7% in EUR, and +10.1% in GBP for the quarter.

Longs listed in the USA, Great Britain, the Eurozone, Switzerland, Denmark, Norway, Hong Kong, Japan, and in Australia contributed positively for the month. Longs listed in Canada, Sweden, and in Singapore detracted from March's performance. Our top Longs for the month were three European banks. We bought shares in a handful of European banks roughly a year ago when the US was experiencing a regional banking crisis. European bank shares fell in sympathy, which offered an attractive opportunity that we seized upon. These European bank shares have done very well for us over the past year. Our worst-performing Longs were a luxury goods group, a convenience store operator, and a Chinese technology group. Notwithstanding this technology group's negative contribution for the month, overall our Longs listed in Hong Kong did well, contributing more than 1% to the fund's March return. For the quarter, Longs contributed more than 10%.

Shorts listed in the USA and in Denmark contributed positively for the month. Shorts listed in Great Britain, the Eurozone, Switzerland, Norway, and in Sweden detracted from the fund's March return. Our top Shorts were an emerging market online retailer, a software-as-a-service provider, and an electric vehicle manufacturer. Our worst-performing Shorts were a chemicals group, an enterprise software provider, and an autonomous vehicle company. It is pleasing that, overall, our Shorts broke even for the month, even though most indices rose sharply. For the quarter, Short detracted 0.4%.

We held no Special Situation or Future & Option positions in the fund during March, nor during the quarter. Currency translation detracted marginally from the fund's March USD return. For the quarter, Currency translation detracted 0.4% from the fund's USD return.

The fund has had a strong first quarter of the year, and we look forward to maintaining this momentum.

💭 Fund Risk

Leverage Risk:	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
Derivative Risk:	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.
Counterparty Credit Risk	Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.
Volatility Risk:	Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.
Concentration and Sector Risk:	A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.
Correlation Risk:	A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include equity pairs trading, fixed income curve trading and commodities pairs trading.

Highest & Lowest Return:	The highest and lowest rolling twelve-month performance of the portfolio since inception.
Total Expense Ratio (TER):	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.
Transaction Costs (TC):	Is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.
Total Investment Charge (TIC):	Should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager.
Total Investment Charges (TIC%):	= TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
Leverage/Gearing:	The use of securities, including derivative instruments, short positions or borrowed capital to increase the exposure beyond the capital employed to an investment.
Alpha:	Denoted the outperformance of the fund over the benchmark.
Sharpe Ratio:	The ratio of excess return over the risk-free rate divided by the total volatility of the portfolio.
Sortino Ratio:	The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.
Standard Deviation:	The deviation of the return of the portfolio relative to its average.
Drawdown:	The greatest peak to trough loss until a new peak is reached.
Correlation	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
Value at Risk (VaR):	Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.
