How has the fund performed?



Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$928 (that is 9.28% of his initial \$10,000). This gives Anthony a return after tax of \$824 for the year.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes

1. The fund has changed its name on 31 October 2025. It was previously named Stewart Investors Worldwide Leaders Sustainability Fund.
2. A combination of actual fund returns, and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. Market index returns have been used until 30 September 2022 and fund returns thereafter. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.
