What is the purpose of this update?

This document tells you how the Aurora Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: To deliver returns exceeding the CPI by 2.5% per annum before fees and tax, over a suggested investment timeframe of 3 to 5 years.

Strategy: Diversified fund aiming to provide moderate investment returns. It invests in mostly income assets and includes some growth assets. The underlying portfolio is actively managed and includes cash, fixed interest, infrastructure, Australasian equities and international equities. Environmental, Social and Governance (ESG) and sustainability considerations are integrated into portfolio decision-making.

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$600 (that is 6.00% of his initial \$10,000). Anthony also paid \$36.00 in other charges. This gives Anthony a total return after tax of \$452 for the year.

What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes

- ^{i.} A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
