Description of this fund


The Fund provides a diversified exposure to New Zealand and Australian equities that meet certain ethical investment criteria.

The investment objective of the Fund is to exceed the return of the S&P/NZX50 Portfolio Gross Index over rolling three year periods, before taking into account fees and expenses.

What are the risks of investing?

Risk indicator for the Trust Management - ESG Australasian Share Fund:



Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


The Smith Charitable Trust had \$100,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, the Smith Charitable Trust received a return after fund charges were deducted of \$2,090 (that is 2.09% of the initial \$100,000). This gives the Smith Charitable Trust a total return after tax of \$2,010 for the year.


