Fund Update for the quarter ended: 30 September 2023

This fund update was first made publicly available on 26 October 2023.

What is the purpose of this update?

This document tells you how the Trust Management - ESG Australasian Share Fund has performed and what fees were charged. The document will help you to compare the Fund with other funds. Trust Investments Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund provides a diversified exposure to New Zealand and Australian equities that meet certain ethical investment criteria.

The investment objective of the Fund is to exceed the return of the S&P/NZX50 Portfolio Index over rolling three-year periods, before taking into account fees and expenses.

What are the risks of investing?

Risk indicator for the Trust Management - ESG Australasian Share Fund¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

The Smith Charitable Trust had \$100,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, the Smith Charitable Trust received a return after fund charges were deducted of \$2,520 (that is 2.52% of the initial \$100,000). This gives the Smith Charitable Trust a total return after tax of \$2,070 for the year.






Notes

1. As the Fund has been operating for less than five years, we have used a mix of actual and market index returns for the five-year period to 30 September 2023 to calculate the risk indicator. The risk indicator is based on the market index returns for the 1 year 6 months to 31 March 2020 when the Fund was not in existence, and then the actual returns for the 3 years 6 months to 30 September 2023. Therefore, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund.
