What is the purpose of this update?

This document tells you how the Bitcoin ETF PIE Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: The fund targets a return before fees and tax that broadly tracks the S&P Bitcoin Index in New Zealand dollars.

Strategy: The fund is designed to provide investors with exposure to Bitcoin within a PIE compliant fund. This is achieved by investing in one or more listed offshore domiciled funds which invest directly in Bitcoin. This is a highly speculative investment. Bitcoin is a highly volatile asset which means this fund will not be appropriate for all investors.

How has the fund performed?



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$7,509 (that is 75.09% of his initial \$10,000). This gives Anthony a return after tax of \$7,301 for the year.

Notes

1.	A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not
