What is the purpose of this update?

This document tells you how the Aurora RetirementPlus Age 65 has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: RetirementPlus age 65 is a representation of the RetirementPlus life cycle.

Strategy: This investment option invests 50% in the Aurora Growth Fund and 50% in the Aurora Conservative Fund.

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$551 (that is 5.51% of his initial \$10,000). Antony also paid \$36 in other charges. This gives Anthony a return after tax of \$412 for the year.


What does the fund invest in?
