

# Fund Update

## What is the purpose of this update?

This document tells you how the Vault International Bitcoin Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

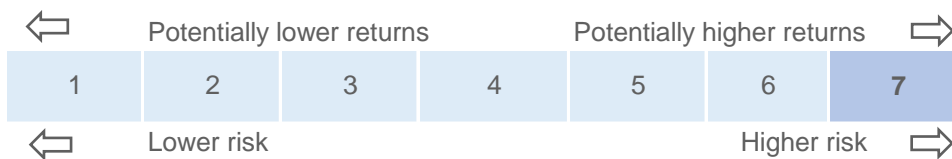
**Objective:** The fund targets a return before fees and tax that broadly tracks the S&P Bitcoin Index in New Zealand dollars.

**Strategy:** The fund is designed to provide investors with exposure to Bitcoin within a PIE compliant fund. This is achieved by investing in one or more listed offshore domiciled funds which invest directly in Bitcoin. This is a highly speculative investment. Bitcoin is a highly volatile asset which means this fund will not be appropriate for all investors.

## What are the risks of investing?<sup>1</sup>

Risk indicator for the Vault International Bitcoin Fund.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

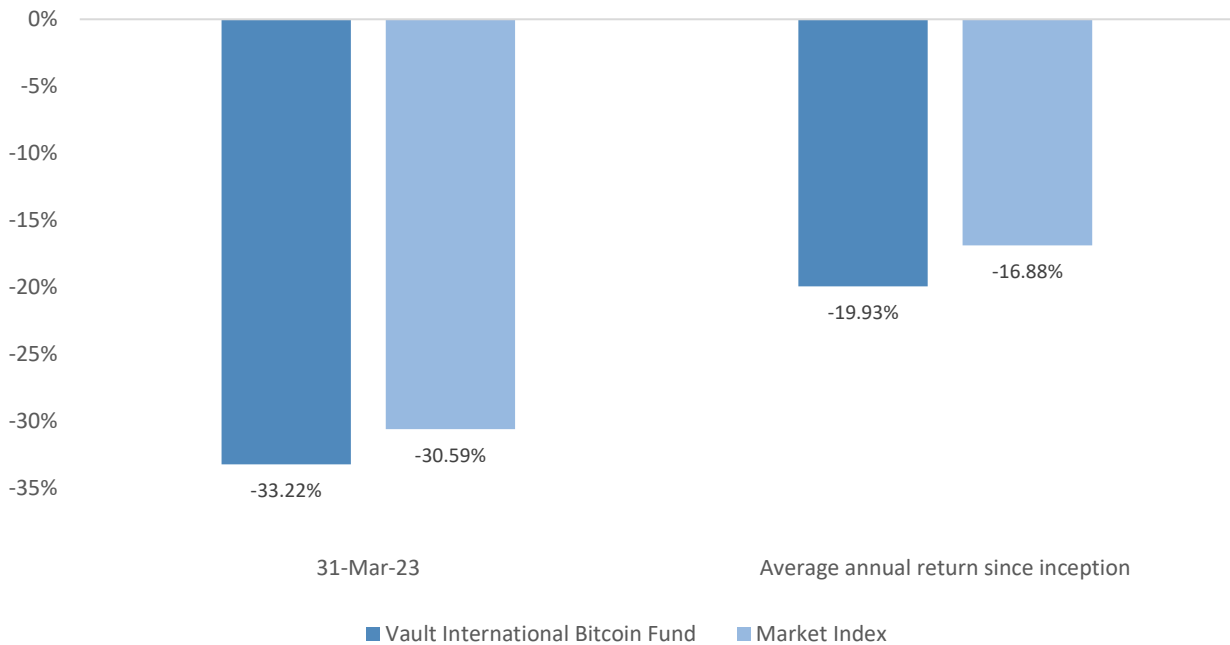

### How has the fund performed?

## What fees are investors charged?

Investors in the Vault International Bitcoin Fund are charged fund charges. In the year to 31 March 2023 these were:

## Example of how this applies to an investor

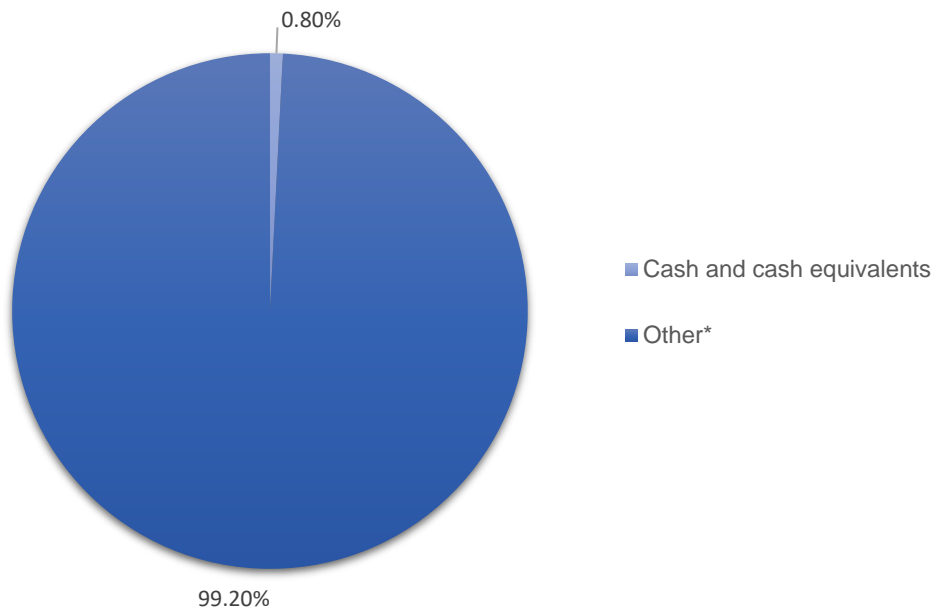
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$2,732 (that is 27.32% of his initial \$10,000). This gives Anthony a total return after tax of \$2,588 for the year.

### What does the fund invest in?

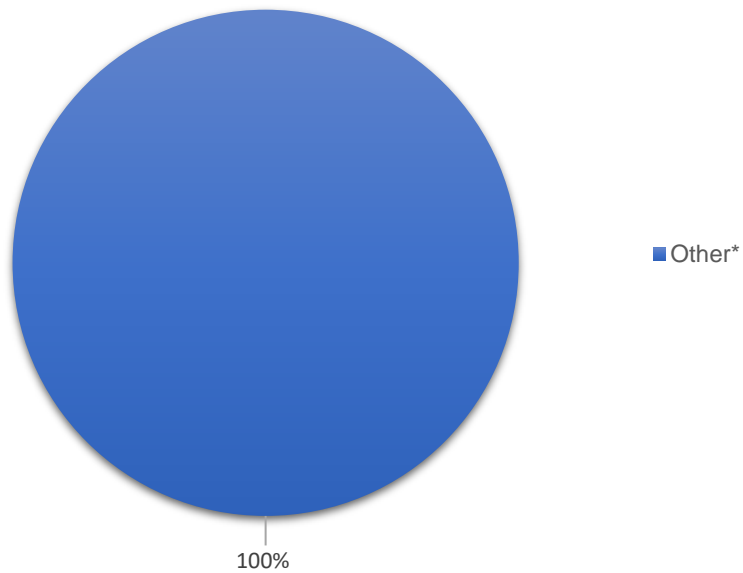
This shows the types of assets that the fund invests in.

## Notes

1 A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. Market index returns have been used until September 2021 and fund returns thereafter. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.

2 The bar chart shows fund returns after deducting fees and tax. Tax is deducted at the highest Prescribed Investor Rate of 28%. However, the market index returns are shown before deducting fees and tax.
