Objective and investment policy

Objective:

The investment objective of the Fund is to preserve capital and generate income and capital growth over the long-term.

The Fund is suitable for investors looking for a balanced investment approach.

Policy:

- The Fund aims to achieve its objective by investing primarily in passive and actively managed collective investment schemes (OEICs, unit trusts and exchange-traded funds) and closed ended investment companies gaining exposure to global fixed income securities, global equity securities, property securities, infrastructure securities and alternative asset classes.
- The Fund will also have the ability to invest in equities, bonds, money market instruments, cash and near cash deposits.
- The Fund will not invest more than 25% in any single collective investment scheme.
- The Fund may invest up to a maximum of 85% in equities.
- Use may also be made of derivatives for efficient portfolio management purposes.
- The asset allocation of the Fund will be constructed and managed in such a way as to ensure there is diversity within the Fund both by geography and investment sector, but with a bias to sterling assets that reflects the likely residency of most of the Fund's investors.

Benchmark:

- The Fund will use the IA Mixed Investments 40-85% Shares sector average as a comparator benchmark for performance monitoring purposes.
- As the benchmark reflects the peer group, which takes a similar level of risk, it is an appropriate benchmark for investors to use to measure the return on the Fund.

Other information:

- You can buy and sell shares on most business days where the London Stock Exchange is open for a full range of services.
- The Fund's base currency is Pounds Sterling. We carry out investors' requests, to buy, sell or switch, at midday on each business day (which excludes UK public holidays). If we receive a request after midday, we deal with it on the next business day.
- The portfolio is suitable for investors that are willing to invest for the medium-term and accept some short-term price volatility in order to generate sustained longer-term capital growth and income.
- There can be no guarantee that the objective of the Fund will be achieved.
- On encashment, particularly in the short-term, you may receive less than the original amount invested. If you hold accumulation shares, income from investments in the Fund will be rolled up into the value of your shares.
- As you hold income shares, income from investments in the Fund will be paid out to you twice a year.

• Non-UCITS Retail Schemes (NURS) - The Fund is classed as a NURS and can have wider investment and borrowing powers than a UCITS scheme with higher investment limits in various areas. It can also invest to a greater extent in areas such as property and unregulated schemes and have the option to borrow on a permanent basis. Such additional powers can increase potential reward, but may also increase risk.

• Exchange Traded Funds - The Fund may invest in Exchange Traded Funds which represent a basket of securities that are traded on an exchange and may not necessarily trade at the net asset value of their underlying holdings. As a result, they may trade at a price that is above or below the value of the underlying portfolio.

• Overseas bonds and currencies - From time to time, a Fund may invest in overseas bonds and currencies. These markets may respond to different influences to those that affect the underlying funds and accordingly carry a higher degree of risk.

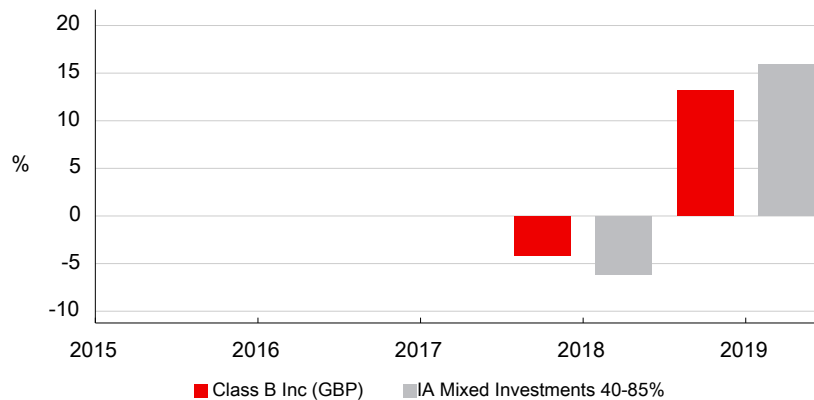
